11 12 in amendment) by striking out the following: "20" and inserting the following: '21'

12 Amend the amendment in the 2nd paragraph after the title in the 3rd line (page 1, line  
13 15 in amendment) by striking out the following: "Eight" and inserting the following: 'Nine'

14 Amend the amendment in the 5th paragraph after the title in subparagraph (7) in the  
15 last line (page 1, line 23 in amendment) by striking out the following: "and"

16 Amend the amendment in the 5th paragraph after the title by inserting after  
17 subparagraph (8) the following:

18 '(9) A representative of a statewide organization representing sportsmen in the  
19 State; and'

20 Amend the amendment by inserting after the 6th paragraph after the title the following:

21 'Amend the bill in section 2 in §8006 in subsection 2 in the 4th line (page 2, line 18 in  
22 L.D.) by striking out the following: "10" and inserting the following: '11''

23 Amend the amendment by relettering or renumbering any nonconsecutive Part letter or  
24 section number to read consecutively.

**SUMMARY**

26 This amendment adds to the committee amendment a member, to be appointed by the  
27 President of the Senate, to the Maine Forest Advisory Board who represents a statewide  
28 organization representing sportsmen. The amendment increases the number of members  
29 necessary for a quorum from 10 to 11.
