1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 22 MRSA §5106, sub-§13, as amended by PL 2011, c. 657, Pt. BB, §9, is further amended to read:
4 5 6	13. Coordinate activities. Coordinate activities and cooperate with programs in this and other states for the common advancement of programs for Maine's aging population and incapacitated and dependent adults; and
7	Sec. 2. 22 MRSA §5106, sub-§14-A is enacted to read:
8 9	14-A. Housing coordinator. Support and maintain a housing coordinator under section 5107-K; and
10	Sec. 3. 22 MRSA §5107-K is enacted to read:
11	§5107-K. Housing coordinator
12 13	1. Housing coordinator. There is established within the department the position of housing coordinator.
14	2. Duties. The housing coordinator shall:
15 16 17	A. Collaborate with other state agencies, aging and disability service providers and organizations and others to develop, maintain, update and make publicly available information and resources regarding housing assistance;

Identify gaps in housing assistance needs of persons with a disability or 60 years of age or older and periodically submit a report on any gaps to the director of the department's office of aging and disability services for inclusion in the state plan on aging under section 5106, subsection 4; and
22 23	C. Establish partnerships with other public and private health agencies and organizations.
24	SUMMARY
25 26	This bill creates within the Department of Health and Human Services a housing coordinator who:
27	1. Collaborates with other state agencies, aging and disability service providers and

1. Collaborates with other state agencies, aging and disability service providers and organizations to maintain and make publicly available housing assistance information and resources;

- 2. Identifies gaps in housing assistance needs of older adults and persons with disabilities and periodically submits a report on the gaps to the director of the Department of Health and Human Services' office of aging and disability services for inclusion in the comprehensive state plan on aging; and
- 3. Establishes partnerships with other public and private health agencies and organizations.
