**Resolve, To Place a Temporary Moratorium on the Approval of Any  
New Motor Vehicle Registration Plates and Initiate a Registration  
Plate Working Group**

1           **Emergency preamble. Whereas,** acts and resolves of the Legislature do not  
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3           **Whereas,** the continued increase in the variety of available registration plates has  
4 created logistical complications in the manufacture, storage and administration of  
5 registration plates and imposed a considerable administrative burden on municipalities and  
6 other political subdivisions of the State performing registrations; and

7           **Whereas,** there is an absence of a strategic plan for the growth and usage of  
8 registration plates; and

9           **Whereas,** there is an immediate need to clearly define the role of specialty registration  
10 plates used for fund-raising by government and private entities under the Maine Revised  
11 Statutes, Title 29-A, section 468; and

12           **Whereas,** specialty registration plates could convey messages that are considered  
13 controversial, unfair or not uniformly representative of other points of view; and

14           **Whereas,** in the judgment of the Legislature, these facts create an emergency within  
15 the meaning of the Constitution of Maine and require the following legislation as  
16 immediately necessary for the preservation of the public peace, health and safety; now,  
17 therefore, be it

18           **Sec. 1. Temporary moratorium. Resolved:** That the Department of the  
19 Secretary of State, Bureau of Motor Vehicles, notwithstanding the Maine Revised Statutes  
20 Title 29-A, sections 468 and 468-A, may not approve any specialty or recognition plate  
21 sponsor to begin the specialty or recognition plate signature gathering process, bring forth  
22 enabling legislation or otherwise initiate any new designs, redesigns or additional  
23 registration plates other than already approved and enacted for a period of 2 years from the  
24 effective date of this resolve. The joint standing committee of the Legislature having  
25 jurisdiction over transportation matters may not consider or review any additional  
26 registration plate designs during this same period.

27           **Sec. 2. Registration plate working group. Resolved:** That the Department of  
28 the Secretary of State, Bureau of Motor Vehicles shall convene a working group to study  
29 the proliferation of registration plates in accordance with this section, referred to in this  
30 section as "the working group."

31           **1. Membership.** The chairs of the Joint Standing Committee on Transportation shall  
32 appoint to the working group:

33           A. The Secretary of State or a designee of the Secretary of State;

34           B. Two members of the Joint Standing Committee on Transportation;

35           C. The deputy secretary of state for the Bureau of Motor Vehicles or a designee of the  
36 deputy secretary;

37           D. A representative of the Secretary of State's technology and information services  
38 staff;

39           E. A representative of the motor vehicle inspection unit of the Maine State Police;

40           F. A representative of a state agency that is a recipient of funds from the Specialty  
41 License Plate Fund under the Maine Revised Statutes, Title 29-A, section 469;

1 G. A representative of a municipality or other political subdivision of the State engaged  
2 in the registration of motor vehicles on behalf of the State; and

3 H. A representative of the State Prison who is responsible for overseeing the  
4 manufacture of registration plates pursuant to the Maine Revised Statutes, Title 29-A,  
5 section 451, subsection 6.

6 **2. Compensation.** Members of the working group may not be compensated for their  
7 work on the working group.

8 **3. Duties.** Duties of the working group include:

9 A. Identifying and documenting the roles and functions of the State's registration  
10 plates;

11 B. Exploring and documenting challenges with the registration plate manufacturing  
12 process;

13 C. Exploring the challenges of storing and securing registration plate inventories in  
14 municipalities and other political subdivisions of the State and in branch offices of the  
15 Bureau of Motor Vehicles;

16 D. Examining the benefits, detriments and legal issues arising from specialty  
17 registration plates;

18 E. Examining competing interests with specialty registration plates;

19 F. Examining standards and systems developed by national and industry experts and  
20 exploring ways in which the State can adopt such standards and systems; and

21 G. Making recommendations based on the findings of the working group.

22 **4. Report.** The Bureau of Motor Vehicles shall provide a report by February 1, 2022  
23 containing the findings and recommendations of the working group to the Joint Standing  
24 Committee on Transportation, and the joint standing committee may introduce legislation  
25 based on those recommendations during the Second Regular Session of the 130th  
26 Legislature.

27 **Emergency clause.** In view of the emergency cited in the preamble, this legislation  
28 takes effect when approved.

## 29 SUMMARY

30 This resolve halts for a period of 2 years the commencement, review and approval of  
31 any new registration plates by the Department of the Secretary of State, Bureau of Motor  
32 Vehicles and the joint standing committee of the Legislature having jurisdiction over  
33 transportation matters. The resolve directs the Bureau of Motor Vehicles to convene a  
34 working group to study the proliferation of registration plates and resulting challenges and  
35 concerns and to make a report to the Joint Standing Committee on Transportation and  
36 authorizes the joint standing committee to introduce legislation based on the report.
