Initiative: Deallocates funding for grants to municipalities for the costs of landfill closure  
and remediation.

#### Fiscal Detail and Notes

This amendment adds an implementation date of February 1, 2023 for the changed definition of "waste generated within the State". Delaying the start date will restore \$218,750 of the Other Special Revenue Funds revenue loss reflected in Committee "A" in fiscal year 2022-23 and the allocation for that amount is restored as well. As amended, the bill will still reduce Other Special Revenue Funds by \$156,250 in fiscal year 2022-23 and continue to reduce by \$375,000 in subsequent years.
