Instruction in American history, African American studies, Maine studies and, Maine Native American history and the history of genocide 18 19 Instruction in American history, African American studies, government, citizenship 20 and, Maine studies and the history of genocide must be aligned with the parameters for 21 essential instruction and graduation requirements established under section 6209. 22 1. American history. American history, government and citizenship, including the 23 Constitution of the United States Constitution, the Declaration of Independence, the 24 importance of voting and the privileges and responsibilities of citizenship, must be taught 25 in and required for graduation from all elementary and secondary schools, both public and 26 private. African American studies must be included in the review of content standards and performance indicators of the system of learning results conducted in accordance with 27 28 section 6209, subsection 4. 29 2. Maine studies. Maine history, including the Constitution of Maine, Maine geography and environment and the natural, industrial and economic resources of Maine 30 and Maine's cultural and ethnic heritage, must be taught. A required component of Maine 31 32 studies is Maine Native American studies, which, Maine Native American studies and Maine African American studies must be included in the review of content standards and 33 performance indicators of the learning results conducted in accordance with section 6209, 34

subsection 4. The Maine Native American studies must address the following topics:

7 8 9	3. History of genocide. The history of genocide, including the Holocaust, must be included in the review of content standards and performance indicators of the system of learning results conducted in accordance with section 6209, subsection 4.
10 11	Amend the bill in section 2 in subsection 2 in the 11th line (page 2, line 3 in L.D.) by inserting after the following: "pursuant to" the following: 'the Maine Revised Statutes,'
12 13	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
14	SUMMARY
15 16 17 18 19 20	This amendment, which is the majority report of the committee, removes the requirement that African American studies and Maine African American studies be taught and required for graduation and provides that African American studies, Maine African American studies and the history of genocide must be included in the content standards and performance indicators of the system of learning results conducted in accordance with the Maine Revised Statutes, Title 20-A, section 6209, subsection 4.
