### **An Act To Integrate African American Studies into American History Education**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA §4706**, as amended by PL 2009, c. 313, §§8 and 9, is further  
3 amended to read:

4 **§4706. Instruction in American history, African American studies, Maine studies and**  
5 **Maine Native American history**

6 Instruction in American history, African American studies, government, citizenship  
7 and Maine studies must be aligned with the parameters for essential instruction and  
8 graduation requirements established under section 6209.

9 **1. American history.** American history, government and citizenship, including the  
10 Constitution of the United States, the Declaration of Independence, the importance of  
11 voting ~~and~~, the privileges and responsibilities of citizenship, and African American studies,  
12 including African American cultural systems and the experience of African Americans  
13 throughout American history, must be taught in and required for graduation from all  
14 elementary and secondary schools, both public and private. African American studies must  
15 be included in the review of content standards and performance indicators of the system of  
16 learning results conducted in accordance with section 6209, subsection 4.

17 **2. Maine studies.** Maine history, including the Constitution of Maine, Maine  
18 geography and environment and the natural, industrial and economic resources of Maine  
19 and Maine's cultural and ethnic heritage, must be taught. ~~A required component~~ Required  
20 components of Maine studies is are Maine Native American studies and Maine African  
21 American studies, which must be included in the review of content standards and  
22 performance indicators of the learning results conducted in accordance with section 6209,  
23 subsection 4. The Maine Native American studies must address the following topics:

- 24 A. Maine tribal governments and political systems and their relationship with local,  
25 state, national and international governments;
- 26 B. Maine Native American cultural systems and the experience of Maine tribal people  
27 throughout history;
- 28 C. Maine Native American territories; and
- 29 D. Maine Native American economic systems.

30 **Sec. 2. Resource development; advisory group; curriculum audit; report.**

31 The Department of Education is responsible for fulfilling the requirements of this section.

32 **1. Development of resources.** The department shall identify and make available to  
33 schools resources and materials for teaching African American studies, including Maine  
34 African American studies, pursuant to this Act.

35 **2. Advisory group.** The department shall, within 30 days after the effective date of  
36 this Act, convene a volunteer advisory group to collect information and prepare materials  
37 for the teaching of African American studies and Maine African American studies. The  
38 advisory group must include scholars of African American history and culture;  
39 representatives from African American civil rights organizations in the State, African  
40 American history and cultural organizations and the Gerald E. Talbot Collection at the  
41 University of Southern Maine; the Maine State Archivist; and members of the public with  
42 personal experience that would inform the collection of information and preparation of

1 materials under this section. The department shall include at least one member from the  
2 advisory group in any group or committee convened to review the parameters for essential  
3 instruction and graduation requirements for social studies pursuant to Title 20-A, section  
4 6209, subsection 4.

5 **3. Guidance; best practices; exemplar modules.** The department shall develop  
6 guidance, best practices and exemplar modules to support the integration of African  
7 American studies and Maine African American studies into the instruction of American  
8 history and Maine history.

9 **4. Curriculum audit.** The department shall develop a process that supports and  
10 enables a local school administrative unit to conduct an internal audit of its curriculum to  
11 ensure an equitable representation of African American voices and an accurate historical  
12 account of African American history and culture.

13 **5. Reporting.** The department shall submit a report on the progress of the  
14 implementation of this Act to the joint standing committee of the Legislature having  
15 jurisdiction over education matters no later than April 1, 2022.

16 **Sec. 3. Effective date.** That section of this Act that amends the Maine Revised  
17 Statutes, Title 20-A, section 4706 takes effect July 1, 2023.

## 18 SUMMARY

19 This bill includes instruction on African American studies and Maine African  
20 American studies, including African American cultural systems and the experience of  
21 African Americans throughout American history, in the Department of Education's  
22 required units of instruction on American history and Maine studies. The bill requires the  
23 department to convene a volunteer advisory committee to collect information and prepare  
24 materials for teaching African American studies and Maine African American studies and  
25 to develop and provide guidance, best practices and exemplar modules to local school  
26 administrative units to integrate African American studies and Maine African American  
27 studies into their curriculum. The bill also requires the department to develop a process to  
28 enable a local school administrative unit to conduct an internal audit of its curriculum to  
29 ensure an equitable representation of African American voices and an accurate historical  
30 account of African American history and culture. The bill also requires the department to  
31 submit a report on the progress of the implementation of this Act to the joint standing  
32 committee of the Legislature having jurisdiction over education matters no later than April  
33 1, 2022.
