## An Act To Address Student Hunger through Expanding Access to Free School Meals

A school or school administrative unit shall request the parent or guardian of each student to complete a household income form provided by the department to determine a family's economic status to determine eligibility for state and federal food assistance programs under this subchapter. This requirement does not apply if the school or school administrative unit is able to obtain equivalent information through another means.

**Sec. 6. Participation in federal universal meal options.** To the maximum extent possible, a school administrative unit that serves breakfast or lunch and is eligible for the community eligibility provision under the federal Healthy, Hunger-Free Kids Act of 2010, Public Law, 111-296, Section 104(a) or other federal universal meal programs shall maximize participation in the programs including the federal resources available in those programs by expanding access to breakfast and lunch at no cost for all eligible students at a school.

## SUMMARY

9 This bill requires the State to pay the difference between the federal requirement for a 10 free breakfast or lunch and the full price for a breakfast or lunch at no cost to the students 11 who are ineligible for free or reduced-price school meals. It also directs schools and school 12 administrative units to request parents and guardians to complete household income forms 13 to determine eligibility for various state and federal food assistance programs. This bill 14 also directs school administrative units to the maximum extent possible to maximize 15 participation in federal school meal programs.
