25 **SUMMARY**

26 This amendment is the minority report of the committee. It deletes the subpoena power
 27 the bill authorizes the executive director of the Maine Commission on Indigent Legal
 28 Services to exercise. It retains the funding for the increase in the salary range of the
 29 executive director, the increase in the reimbursement rate for indigent legal services from
 30 \$60 to \$80 per hour, the funding for projected costs of the commission and the funding for
 31 6 additional central office staff positions for supervision and auditing.

Fiscal Detail and Notes

This bill includes General Fund appropriations to the Maine Commission on Indigent Legal Services (MCILS) of \$9,264,301 in fiscal year 2021-22 and \$9,266,244 in fiscal year 2022-23 for an increase in the salary range for the Executive Director of MCILS, raising the reimbursement rate for indigent legal services from \$60 per hour to \$80, providing additional All Other funding to reflect actual costs of the MCILS, establishing 6 positions and providing All Other funding for the supervision subdivision.
