21 County that can be managed for public benefits such as recreational access, wildlife habitat

## Fiscal Note

### Fiscal Detail and Notes

This bill authorizes, but does not direct, the Department of Agriculture, Conservation and Forestry (ACF) to sell interest in certain parcels of land held in common and undivided interest in T. 4, R. 8 in Penobscot County to Baxter State Park. This conveyance will increase revenue to the County Specific Reserved Lands Acquisition Fund in ACF. The amount will not be known until an appraisal is completed. It is anticipated that Baxter State Park has sufficient funding available to complete the purchase.
