6 7 **Sec. 1. 21-A MRSA §1015, sub-§2,** as repealed and replaced by PL 2021, c. 274, §5 and affected by §13, is amended to read:

2. Contributions by party committees, ballot question committees and political action committees. Except as provided in paragraph A, <u>a ballot question committee</u>, a party committee under section 1013-A, subsection 3, a political action committee and any other committee may not make contributions to a candidate.

- 8 A. A party committee under section 1013-A, subsection 3, a ballot question committee, 9 a leadership political action committee, a separate segregated fund committee, a caucus 10 political action committee and any other political action committee may make contributions to a candidate in support of the candidacy of one person aggregating no 11 more than the amount that an individual may contribute to that candidate under 12 13 subsection 1, except that the committee may not make any monetary contributions to a 14 candidate using funds that derive, in whole or in part, from a business entity. Nothing in this paragraph prohibits a separate segregated fund committee that receives 15 16 nonmonetary contributions from a business entity under section 1056-D, subsection 2, paragraph A from making monetary contributions to a candidate within the limits 17 18 described in this paragraph.

Contributions by party committees, ballot question committees and political
 action committees. Except as provided in paragraph A, a party committee under section
 1013-A, subsection 3, <u>a ballot question committee</u>, a political action committee and any
 other committee may not make contributions to a leadership political action committee.

A party committee under section 1013-A, subsection 3, a ballot question committee, a leadership political action committee, a separate segregated fund committee, a caucus 26 27 political action committee and any other political action committee may make contributions to a leadership political action committee aggregating no more in a 28 29 calendar year than the amount that the committee may contribute to a legislative 30 candidate in any election under section 1015, subsection 2, paragraph A, except that 31 the committee may not make any monetary contributions to a leadership political action committee using funds that derive, in whole or in part, from a business entity. Nothing 32 33 in this paragraph prohibits a separate segregated fund committee that receives nonmonetary contributions from a business entity under section 1056-D, subsection 2, 34 35 paragraph A from making monetary contributions to a candidate within the limits 36 described in this paragraph.

- Contributions by individuals. An individual may not make contributions to a separate segregated fund committee aggregating more than \$5,000 in a calendar year.
 Beginning December 1, 2023, contribution limits under this subsection are adjusted every 2 years based on the Consumer Price Index as reported by the United States Department of Labor, Bureau of Labor Statistics and rounded to the nearest amount divisible by \$25. The commission shall post the current contribution limit and the amount of the next adjustment

The parent entity may also provide the separate segregated fund committee with the use of offices, telephones, computers and similar equipment when that use does not result in additional cost to the parent entity.

14	SUMMARY
15 16	This bill makes the following changes to campaign finance law effective January 1, 2023.
17 18 19	1. It clarifies that a ballot question committee may make contributions to a candidate up to the applicable limit as long as the funds for the contributions are not derived from a business entity.
20 21 22 23	2. It clarifies that a ballot question committee may make contributions to a leadership political action committee that do not aggregate more than the limit applicable for legislative candidates as long as the funds for the contributions are not derived from a business entity.
24 25 26	3. It provides for the biennial adjustment of the limit on the amount an individual may contribute to a separate segregated fund committee. The biennial adjustment is based on the Consumer Price Index.
27 28 29	4. It allows a corporation, membership organization, cooperative or labor or other organization to contribute the paid staff time of its employees and independent contractors to a separate segregated fund committee it has established.
