From December 31, 2022 to February 1, 2023 the date by which the department must 23 issue final rate letters implementing the reimbursement option chosen by each federally 24 qualified health center; and 25 4. #### Fiscal Detail and Notes

This amendment changes the effective date from July 1, 2022 to March 1, 2023. This change reduces the General Fund appropriations to the Department of Health and Human Services from \$5,215,763 in fiscal year 2022-23 to \$1,529,628 in fiscal year 2022-23. Federal Expenditures Fund and Federal Block Grant Fund allocations are also reduced in fiscal year 2022-23.
