Amend the amendment by inserting after the title the following:

'Amend the bill by striking out all of sections 1, 2, 3, 4 and 5.'

Amend the amendment by striking out all of the first paragraph after the title (page 1,
line 12 in amendment).

Amend the amendment by striking out all of section 6.

Amend the amendment by inserting after section 10 the following:

'Amend the bill by striking out all of section 10.'

Amend the amendment by striking out all of the 7th paragraph (page 1, line 25 in
amendment).


Amend the amendment by striking out all of section 11.

Fiscal Detail and Notes

Removing the Maine Community College System from the requirements of this legislation will eliminate the need for ongoing General Fund appropriations of \$20,000 per year beginning in fiscal year 2022-23 to the Maine Community College System for the costs associated with adding one full-time faculty member, one adjunct faculty member and one full-time nonfaculty member to its Board of Trustees.
