An Act To Establish the Safe Homes Program

4 5 6 7	The month of September of each year is designated as Safe Homes Awareness Month and the Governor shall annually issue a proclamation to raise awareness among the people of the State of the importance of safety in the home and of the existence of and assistance that is available from the Safe Homes Program established in Title 25, section 7001.

14 15	1. Definitions. As used in this section, unless the context otherwise indicates, the following terms have the following meanings.
16 17	A. "Dangerous weapon" has the same meaning as in Title 17-A, section 2, subsection 9, paragraph C.
18	B. "Department" means the Department of Public Safety.
19 20 21	C. "Designated groups" means public schools, public preschool programs, foster homes, veterans programs, hospitals or other facilities in which newborns are delivered and members of the public.
22	D. "Firearm" has the same meaning as in Title 17-A, section 2, subsection 12-A.
23 24	E. "Foster home" means a family foster home as defined in Title 22, section 8101, subsection 3.
25 26	F. "Prescription drug" has the same meaning as in Title 22, section 8731, subsection 3-A.
27 28	G. "Public preschool program" has the same meaning as in Title 20-A, section 1, subsection 23-A.
29	H. "Public school" has the same meaning as in Title 20-A, section 1, subsection 24.
30 31 32 33	2. Program established. The Safe Homes Program is established and administered by the department to support the safe storage of prescription drugs, firearms and dangerous weapons in homes by providing educational information and materials and grants in accordance with this section.
34 35	3. Educational information and materials. The department shall support designated groups that provide educational information and materials on the safe storage of

- prescription drugs, firearms and dangerous weapons in homes. The educational information and materials must include, but are not limited to, information and materials on:
 - A. Veterans programs and other state, community and private resources and programs that are available to assist in achieving the safe storage of prescription drugs, firearms and dangerous weapons in homes; and
 - B. Discounts, incentives and savings programs available from public and private entities, including assistance through the Safe Homes Program Fund established in subsection 5.
 - **4. Grant program.** The department shall develop a grant program to provide funding for the purpose of providing educational information and materials in accordance with subsection 3 and for purchasing firearm safety devices, including, but not limited to, safes, locks and lockboxes designed for securing firearms.
 - A. Grants may be provided under this subsection to designated groups and nonprofit and community organizations serving designated groups.
 - B. The department shall administer the grant program developed pursuant to this subsection through an agreement with a statewide association of sheriffs.
 - C. The department shall adopt rules to implement the grant program. The rules must include procedures for assisting applicants with the application process, accepting applications, approving and disapproving applications and distributing funding, coupons or vouchers to successful applicants. Rules adopted pursuant to this paragraph are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.
 - 5. Safe Homes Program Fund. The Safe Homes Program Fund is established as a nonlapsing fund to provide funding to achieve the purposes of this section. The fund consists of any funds received from private and public sources. The fund must be held separate and apart from all other money, funds and accounts. Any balance remaining in the fund at the end of any fiscal year must be carried forward to the next fiscal year.
 - 6. List. Within available resources, the Commissioner of Public Safety shall maintain a list of state, community and private resources and programs that are available to support the purposes of this section.

31 SUMMARY

This bill establishes the Safe Homes Program administered by the Department of Public Safety to support the safe storage of prescription drugs, firearms and dangerous weapons in homes by providing educational information and materials and grants. Under the bill, grants may be provided to public schools, public preschool programs, foster homes, veterans programs, hospitals or other facilities in which newborns are delivered and members of the public and to nonprofit and community organizations serving those groups for the purpose of providing educational information and materials and for purchasing firearm safety devices. The bill also designates September as Safe Homes Awareness Month.
