### **An Act To Continue Supporting Safe Drinking Water for Maine Families**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. Grants for well water abatement.** The Maine State Housing Authority  
3 shall provide grants to eligible owners of single-family homes or landlords with private  
4 well water that shows evidence of contamination. For purposes of this section,  
5 "contamination" means that the level of microorganisms, disinfectants, disinfection by-  
6 products, inorganic chemicals, organic chemicals or radionuclides exceeds maximum  
7 contaminant levels for public water systems established by the national primary drinking  
8 water regulations, 40 Code of Federal Regulations, Part 141, or similar standards applicable  
9 to public water systems in the State pursuant to state law or rule, and "private well water"  
10 means water from a private drinking water well as defined in the Maine Revised Statutes,  
11 Title 38, section 1392, subsection 8.

12 **Sec. 2. Appropriations and allocations.** The following appropriations and  
13 allocations are made.

14 **HOUSING AUTHORITY, MAINE STATE**

15 **Housing Authority - State 0442**

16 Initiative: Provides one-time funds for grants to eligible owners of single-family homes or  
17 landlords with private well water that shows evidence of contamination.
