COMMITTEE AMENDMENT " $\mathcal{A}$ " to S.P. 678, L.D. 1923 (S·502)

4. It changes the membership of the Board of Directors of the Maine Space Corporation to include representatives from 5 geographic regions of the State as designated by counties;

5. It removes the prohibition of public officials, members of the board of directors or employees of the corporation from acquiring or holding a direct or indirect financial or personal interest in a corporation activity, a corporation property or a contract or proposed contract in connection with a corporation activity. Individuals with an interest in property included or planned to be included in a corporation activity must still disclose this information immediately in writing to the board of directors and recuse themselves from any action by the corporation affecting that property; and

6. It removes the provision establishing the Maine Space Complex Job IncrementFinancing Fund.

## **Fiscal Note**

Minor cost increase - General Fund Minor revenue increase - General Fund

#### **Correctional and Judicial Impact Statements**

Establishes new Class E crimes

The additional workload associated with the minimal number of new cases filed in the court system does not require additional funding at this time. The collection of additional fines may increase General Fund or other dedicated revenue by minor amounts.

#### **Fiscal Detail and Notes**

This bill creates the Maine Space Corporation as a legal entity to establish the State as a national and international industry destination and an authority in launching small launch vehicles and small satellites into polar orbit. The statutory provisions authorized pursuant to this legislation should result in no financial impact on state government or state finances.

Additional costs to the University of Maine System, the Maine Community College System and the Department of Economic and Community Development associated with having representatives serve on the board of directors and to the Finance Authority of Maine associated with issuing the required certificate of approval related to the issuance of bonds can be absorbed within existing budgeted resources.
