12 13	'Emergency preamble. Whereas, acts and resolves of the Legislature do no become effective until 90 days after adjournment unless enacted as emergencies; and
14 15	Whereas, COVID-19 has decreased in-person access to community action agencies that administer fuel assistance; and
16	Whereas, individuals must apply annually for fuel assistance; and
17	Whereas, there is currently no online application for fuel assistance; and
18 19 20	Whereas, this legislation requires the Maine State Housing Authority to adopt rules requiring that online applications for fuel assistance be accepted beginning no later than the next winter season; and
21 22 23 24	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'
25	Amend the bill by adding before the summary the following:
26 27	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'
