COMMITTEE AMENDMENT " A " to S.P. 712, L.D. 1981, "Resolve, Authorizing  
10 the Bureau of Parks and Lands To Authorize Additional Construction and Installations  
11 Related to a Telecommunications Tower on Bald Mountain in the Town of Rangeley"

Amend the resolve in the 4th indented paragraph after the title in the 4th to 6th lines  
13 (page 1, lines 12 to 14 in L.D.) by striking out the following: ", with American Tower a  
14 sublessee of RCC Atlantic, Inc., and American Tower subleases approximately 2 acres of  
15 that property from RCC Atlantic, Inc., on which American Tower" and inserting the  
16 following: 'and American Tower has a management agreement with RCC Atlantic, Inc.  
17 and'

Amend the resolve in section 1 in the first paragraph in the last 2 lines (page 1, lines  
19 23 and 24 in L.D.) by striking out the following: ", RCC Atlantic, Inc. is the lessee and  
20 American Tower is a sublessee" and inserting the following: 'and RCC Atlantic, Inc. is the  
21 lessee and American Tower has a management agreement with RCC Atlantic, Inc. and  
22 presently operates the commercial telecommunications tower'

Amend the resolve by relettering or renumbering any nonconsecutive Part letter or  
24 section number to read consecutively.

This amendment corrects provisions in the resolve stating that American Tower is a  
27 sublessee of RCC Atlantic, Inc. and clarifies that American Tower has a management  
28 agreement with RCC Atlantic, Inc.
