This amendment removes language related to the Department of Corrections' authority to adopt standards, policies and procedures concerning jails and the County Corrections Professional Standards Council's authority to advise the Department of Corrections in adopting those standards, policies and procedures. The amendment replaces "adopting rules governing the operation of jails" with "adopting rules and standards for the jails "
