To qualify for free admission under this section, a person shall present a qualifying tribal identification, as approved by the respective tribal government, to the bureau staff on duty or other designee of the director.'

25 26 27 28 29 30 31 32	This amendment, which replaces the bill, makes a technical change to the bill and clarifies that a member of a federally recognized Indian nation, tribe or band in Maine is not required to pay a fee for admission to not only state-owned parks and historic sites, but also camping areas and beaches managed by the State. The amendment also specifies that to qualify for free admission, a person is required to present a qualifying tribal identification, as approved by the respective tribal government, to the park attendant or other designee of the Director of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry.

#### **Fiscal Detail and Notes**

This bill provides free admission for members of federally recognized Indian nations, tribes and bands to state-owned parks, historic sites, camping areas and beaches. This is estimated to reduce General Fund revenue by \$22,131 in fiscal year 2024-25 and \$29,508 starting in fiscal year 2025-26. This estimate assumes that tribal members will use state-owned parks, historic sites, camping areas and beaches at the same rate as Maine residents and nonresidents.
