| 3 | 8-B. Landlord. "Landlord" means a person who owns a property and allows another |
| 4 | person to use that property in return for payment. |
| 5 | Sec. 2. 22 MRSA §4301, sub-§11-A is enacted to read: |
| 6 | 11-A. Operator. "Operator" means the lawful owner of a recovery residence or an |
| 7 | individual or company designated by the lawful owner to have primary responsibility for |
| 8 | the day-to-day operations of the recovery residence and for acquiring and maintaining |
| 9 10 | certification pursuant to Title 5, section 20005, subsection 22 of the recovery residence in order to receive housing assistance payments through the general assistance program. |

| 13 | 6. Eligibility; recovery residence; exception. The overseer in a municipality may |
| 14 | not deny general assistance to a person for the sole reason that the person is residing in a |
| 15 | recovery residence. Beginning July 1, 2022, a municipality may not provide housing |
| 16 | assistance to a person residing in a recovery residence that has not been certified in |
| 17 | accordance with Title 5, section 20005, subsection 22, except that the person may receive |
| 18 | housing assistance while residing in an uncertified recovery residence for one 30-day |
| 19 | period only and the overseer shall inform the person of the requirements of this subsection. |
| 20 | A person who is ineligible for housing assistance under this subsection may remain eligible |
| 21 22 | to receive general assistance for other basic necessities. <u>Upon request by a person residing</u> in a certified recovery residence who has been determined eligible for housing assistance, |
| 23 | a municipality shall issue a housing assistance payment to the operator of the certified |
| 24 | recovery residence instead of to a landlord. |

| 25 | SUMMARY |
| 26 | This bill requires a municipality to issue a general assistance housing assistance |
| 27 | payment to the operator of a certified recovery residence upon request by an eligible person |
| 28 | rather than to a landlord, including a property owner. |
