The amendment changes the timing of the one-time General Fund appropriations to the Department of Administrative and Financial Services, Bureau of General Services to install diaper changing stations within public restrooms in state-owned public buildings from \$15,000 in fiscal year 2023-24 and \$15,000 in fiscal year 2024-25 to \$30,000 in fiscal year 2024-25.
