31 32 33 34 35	This bill authorizes a designee of the Director of the Maine Emergency Management Agency within the Department of Defense, Veterans and Emergency Management to serve as chair of the State Emergency Response Commission. The bill increases from \$50 to \$100 the maximum fee for registering a facility that is required by federal law to report to the commission. It also makes other clerical changes.

Be it enacted by the People of the State of Maine as follows:

1
