## SUMMARY

This amendment is the minority report of the committee and it replaces the bill The amendment

6 1 Eliminates the exception in the bill to the crime of a violation of privacy if the other 7 person is 14 or 15 years of age and the person who commits the violation of privacy is less 8 than 5 years older than the other person,

9 2 Removes the Class C crime designation for a violation of privacy under certain 10 circumstances, keeping violation of privacy a Class D crime in all instances, and

3 Creates an additional offense of violation of privacy when it is done for the purpose
 of arousing or gratifying the sexual desire of that person or another person. It makes this
 offense a Tier I offense under the Sex Offender Registration and Notification Act of 2013
