Amend the amendment in section 1 in §3173-L in the first indented paragraph in the first line (page 1, line 17 in amendment) by striking out the following: "January 15, 2024" and inserting the following: 'October 1, 2024'

Amend the amendment by striking out all of section 2 and inserting the following:

'Sec. 2. Appropriations and allocations. The following appropriations and allocations are made.

Initiative: Provides funding to contract with a 3rd-party entity to conduct assessments for children who have not attained 21 years of age who the department determines are eligible for private duty nursing and personal care services provided in a residential setting or other setting where normal life activities take place.
