### SUMMARY

This amendment replaces the resolve It requires the Adjutant General to sell a parcel of land to the City of Hallowell, by June 30, 2024, for \$40,000 to be paid by the city in 10 equal annual installments The sale price is less than the appraised value because the appraisal did not account for upkeep to the property made by the city over several years and assumed the highest and best use of the property for residential development The city plans to use this property for public recreational purposes

This bill requires the Department of Defense, Veterans and Emeigency Management to sell a parcel of land to the City of Hallowell for \$40,000, to be paid over a 10-year period.
