COMMITTEE AMENDMENT "A" to H P 171, L D 273, "An Act to Provide Funds to the Malaga 1912 Scholarship Fund"

Amend the bill by striking out everything after the enacting clause and inserting the following:

'Sec. 1. Appropriations and allocations. The following appropriations and allocations are made

EDUCATION, DEPARTMENT OF

General Purpose Aid for Local Schools 0308

Initiative Provides one-time funds for scholarships for descendants of former residents of Malaga Island. The Commissioner of Education shall award these funds to a nonprofit entity to administer the scholarship program
