The use of funds from the fund is in addition to any funds received by the Department of the Secretary of State from the State for this purpose.

- 3. Carry forward; transfer of funds. Notwithstanding any provision of law to the contrary, the State Controller shall carry forward any remaining balances in the Department of Secretary of State, Bureau of Corporations, Elections and Commissions program, General Fund account at the end of fiscal year 2024-25 and each fiscal year thereafter into the following fiscal year and shall transfer those balances each fiscal year to the Department of Secretary of State, Bureau of Corporations, Elections and Commissions program, Production and Delivery of Election Materials Fund, Other Special Revenue Funds account.
- Sec. 2. Working group to study polling places at schools reconvened. The Department of the Secretary of State shall convene a working group, referred to in this section as "the working group," to study the use of school buildings as polling places, to consider options to protect the security of school students and staff and election staff and voters and to consider polling place accessibility. The department shall provide the necessary staffing services to the working group.
 - 1. The working group consists of 9 members as follows:
 - A. The Secretary of State or the secretary's designee;
 - B. The deputy secretary of state of the Bureau of Corporations, Elections and Commissions within the Department of the Secretary of State or the deputy secretary's designee;
 - C. The Commissioner of Education or the commissioner's designee;
- D. A representative of the Maine School Boards Association, appointed by the 22 Secretary of State:
 - E. A representative of the Maine School Superintendents Association, appointed by the Secretary of State;
 - F. A representative of the Maine Town and City Clerks' Association, appointed by the Secretary of State;
 - G. A representative of the Maine Municipal Association, appointed by the Secretary of State;
 - H. A representative of an organization dedicated to advancing the legal rights of individuals with disabilities, appointed by the Secretary of State; and
 - I. A representative of an organization dedicated to the protection of voters who are from historically underrepresented or marginalized communities, appointed by the Secretary of State.
 - 2. To the extent possible, membership in the working group must be the same as the working group convened under Resolve 2023, chapter 73. Members of the working group are not compensated for their participation in the working group.
 - 3. The working group shall:
 - A. Identify the number of school buildings in the State that are designated as polling places;
 - B. Examine and identify practices in other states around the use of school buildings as polling places;

C. Evaluate the criteria necessary to protect the security of school students and staf
and election staff and voters when school buildings are used as polling places;

- D. Identify possible changes to practices around the use of school buildings as polling places to protect voter accessibility and to safeguard the security of school students and staff and election staff and voters when a school building is used as a polling place; and
- E. Make recommendations based on the findings of the working group.
- 4. No later than December 15, 2024, the Department of the Secretary of State shall submit a report that includes the findings and recommendations of the working group, including suggested legislation, to the joint standing committee of the Legislature having jurisdiction over veterans and legal affairs. The committee may report out legislation based on the report to the 132nd Legislature in 2025.

SUMMARY

This amendment replaces the bill, which is a concept draft, and establishes the Production and Delivery of Election Materials Fund as a nonlapsing, interest-bearing Other Special Revenue Funds account within the Department of the Secretary of State for the purpose of receiving funds from the State to support the costs associated with the production and delivery of election materials. The use of funds from the fund is in addition to any other funds received by the department from the State for that purpose.

It also provides for an ongoing transfer to the Production and Delivery of Election Materials Fund from the unappropriated surplus of the General Fund. In 2024 the transfer is \$266,000, and the amount must be adjusted for the cost of living every 2 years. Additionally, it provides for any remaining balances in the Department of Secretary of State, Bureau of Corporations, Elections and Commissions program, General Fund account at the end of each fiscal year to be transferred to the Production and Delivery of Election Materials Fund

Fiscal Detail and Notes

The bill creates the Production and Delivery of Election Materials Fund within the Department of Secretary of State. The bill includes Other Special Revenue Funds allocations to the Department of Secretary of State of \$266,000 beginning in fiscal year 2024-25 to support costs associated with the production and delivery of election materials. The bill provides for annual transfers from the unappropriated surplus of the General Fund to the Fund of \$266,000 beginning in fiscal year 2024-25 to fund the election materials costs.

Additional costs to the Department of Education and the Department of Secretary of State associated with serving on the working group can be absorbed within existing budgeted resources. Additional costs to the Department of Secretary of State associated with submitting the report can also be absorbed within existing budgeted resources.
