Initiative: Deappropriates funds due to the removal of coverage to MaineCare members for legal abortion services.



### Fiscal Detail and Notes

This amendment includes General Fund deappropriations to the Department of Health and Human Services of \$375,843 beginning in fiscal year 2023-24 due to the removal of coverage to MaineCare members for legal abortion services. This amendment maintains a balanced budget.
