COMMITTEE AMENDMENT "A" to HP 289, LD 472, "An Act to Support Certified Community Behavioral Health Clinic Projects"

Amend the bill by striking out all of section 1 and inserting the following:

**Sec. 1. Appropriations and allocations.** The following appropriations and allocations are made

**HEALTH AND HUMAN SERVICES, DEPARTMENT OF  
Mental Health Services - Community Z198**

Initiative Provides funding to bridge the gap for mental health organizations participating in certified community behavioral health clinic projects that have been funded by federal grants from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration for the past 2 years

**SUMMARY**

This amendment changes the appropriation of funding from \$4,000,000 in fiscal year 2023-24 to \$2,000,000 in fiscal year 2023-24 and \$2,000,000 in fiscal year 2024-25. It removes the language in the initiative stating that the funding is one-time funding and ends on June 30, 2024.
