COMMITTEE AMENDMENT "A" to H P 314, L D 497, "An Act to Prohibit the Use of Personal Watercraft on Keyes Pond and Stearns Pond in the Town of Sweden"

Amend the bill by striking out the title and substituting the following

'An Act to Prohibit the Use of Personal Watercraft on Keyes Pond in the Town of Sweden'

Amend the bill in section 3 in subparagraph (34) in the first line (page 1, line 12 in L D) by striking out the following "or Stearns Pond"

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively

SUMMARY

This amendment changes the title and removes Stearns Pond from the proposed addition to the list of water bodies in the State on which the operation of personal watercraft is prohibited
