Amend the amendment by striking out all of section 2 and inserting the following:

**Sec. 2. Appropriations and allocations.** The following appropriations and allocations are made.

Initiative: Provides funding for increased transportation and wait time reimbursement rates for funeral establishments requested to transport a body to Augusta for the Office of Chief Medical Examiner.
