- **Sec. 2. Report.** The Department of Administrative and Financial Services, Bureau of General Services, referred to in this section as "the bureau," shall develop the guidance required by the Maine Revised Statutes, Title 5, section 1754 by December 31, 2024 The bureau shall submit a report to the joint standing committee of the Legislature having jurisdiction over state and local government matters no later than December 31, 2024 detailing the guidance developed The committee may submit legislation relating to the subject matter of the report to the 132nd Legislature in 2025 '

SUMMARY

This amendment replaces the bill and changes the title It requires the Department of Administrative and Financial Services, Bureau of General Services to develop, by December 31, 2024, guidance regarding integration of bird collision risk management into public improvements. The guidance must be developed in consultation with expert stakeholders, include an explanation of architectural design threats and landscape design threats to birds, include an explanation of the cost differentials and the comparative effectiveness of materials, designs and other methods for reducing bird collisions, include an explanation of other considerations for reducing bird collisions, and be available on the bureau's publicly accessible website. The guidance is intended for use in construction of public improvements and renovations of public improvements in which more than 50% of a building facade is substantially altered. The guidance does not apply to public buildings, landscapes or districts listed on the National Register of Historic Places or determined to be eligible for inclusion on the National Register of Historic Places, including the State House and the Blaine House

The bureau must submit a report to the joint standing committee of the Legislature having jurisdiction over state and local government matters no later than December 31, 2024 detailing the guidance developed. The committee may submit legislation relating to the subject matter of the report to the 132nd Legislature. The bureau must submit a report to the joint standing committee of the Legislature having jurisdiction over state and local government matters by December 31, 2026, and biennially thereafter, detailing use of the
