The Commission on Governmental Ethics and Election Practices shall submit a report of its findings, including suggested legislation, to the Joint Standing Committee on Veterans and Legal Affairs by February 1, 2024 The joint standing committee may report out legislation related to the report to the Second Regular Session of the 131st Legislature

Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved '

SUMMARY

This amendment adds an emergency preamble and emergency clause It also requires the Commission on Governmental Ethics and Election Practices, in consultation with the Attorney General, to develop legislation necessary to regulate contributions made by business entities to candidates and political action committees and contributions accepted by leadership political action committees The commission is directed to submit a report by February 1, 2024 to the Joint Standing Committee on Veterans and Legal Affairs, which may report out legislation related to the report to the Second Regular Session of the 131st Legislature
