COMMITTEE AMENDMENT "B" to S P 348, L D 789, "An Act Regarding Dental Licensure for Charitable Care"

Amend the bill by striking out all of section 2 and inserting the following

'Sec. 2. 32 MRSA §18341, sub-§1, as amended by PL 2023, c 17, Pt P, §25, is further amended to read

1. Application. An applicant seeking an initial license or a renewed license must submit an application with the fee established by rule adopted by the director and any other materials required by the board, except that the fee for an initial license or a renewed license for an applicant for a charitable dentist license is \$0

Amend the bill by inserting after section 3 the following

'Sec. 4. Appropriations and allocations. The following appropriations and allocations are made

Fiscal Detail and Notes

This bill includes a one-time Other Special Revenue Funds allocation of \$3,052 in fiscal year 2023-24 to the Board of Dental Practice, affiliated with the Department of Professional and Financial Regulation, for the costs associated with rulemaking. Allowing a dentist licensed in another state or a Canadian province to receive a charitable dentist license at no cost may result in a minor decrease in revenue to the board.
