An Act to Improve Visibility and Restore the Beauty of Maine's Roadways by Limiting Signs in the Public Right-of-way

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 23 MRSA §1913-A, sub-§1, ¶L, as amended by PL 2019, c. 594, §1, is further amended to read:

L. Temporary If allowed by a municipal ordinance or a rule or ordinance adopted by a land use planning committee, temporary signs placed within the public right-of-way for a maximum of 12 weeks per calendar year, except that a temporary sign may not be placed within the public right-of-way for more than 6 weeks from January 1st to June 30th or for more than 6 weeks from July 1st to December 31st. A temporary sign may not be placed within 30 feet of another temporary sign bearing the same or substantially the same message. A temporary sign may not exceed 4 feet by 8 feet in size. A sign under this paragraph must include or be marked with the name and address of the individual, entity or organization that placed the sign within the public right-of-way and the date the sign was erected within the public right-of-way.

SUMMARY

This bill replaces statewide requirements for the placement and duration of installation of temporary signs within the public right-of-way with a provision that imposes the requirements only if signs are allowed by an ordinance or rule adopted by a municipality or land use planning committee.
