day and the candidate's party or political designation, as it is listed on the ballot for the election that day A candidate, or no more than one representative of a candidate, is prohibited from wearing any button, name tag, apparel or label or have or use any item or sign displaying the candidate's name or the name of the office the candidate is seeking or otherwise expresses support for or opposition to a party, a candidate or a ballot question

The amendment also allows a person who is at the polls solely for the purpose of voting to wear clothing or a campaign button that displays a candidate's name or an advertising or campaign message on any public property located within 250 feet of the entrance to either the voting place or the building in which the registrar's office is located As in the bill, it removes the restriction on campaign buttons not exceeding 3 inches
