COMMITTEE AMENDMENT "B" to H P 582, LD 935, "An Act to Remove Barriers to Abortion Coverage in Private Insurance"

Amend the bill by striking out the title and substituting the following
'An Act to Repeal the Requirement for Health Insurance Carriers to Cover Abortion Services'

Amend the bill by striking out everything after the enacting clause and inserting the following

'Sec. 1. 24 MRSA §2317-B, sub-§21, as repealed and replaced by PL 2019, c 605, §2, is amended to read

21. Title 24-A, sections 2765-A and 2847-U. The practice of dental therapy by a dental therapist, Title 24-A, sections 2765-A and 2847-U, and

Sec. 2. 24 MRSA §2317-B, sub-§22, as amended by PL 2019, c 605, §3, is repealed

Sec. 3. 24-A MRSA §4320-M, as enacted by PL 2019, c 274, §5, is repealed '

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively
