Amend the bill in section 1 in §3174-KKK by striking out all of subsection 2 (page 1, lines 13 to 16 in LD) and inserting the following

2. Reimbursement The department shall provide reimbursement for

A Medically necessary treatment for or related to gender dysphoria as defined by the Diagnostic and Statistical Manual of Mental Disorders, 5th edition, published by the American Psychiatric Association or a comparable or equivalent diagnosis,

B Treatment for complications arising from a treatment described by paragraph A, and

C The reversal of a treatment described by paragraph A'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively

These additional requirements would be a medically necessary treatment and MaineCare eligible members already has access to all medically necessary treatment.
