An Act Regarding the Allocation of Funds Awarded to Maine Due to the Opioid Settlement

#### Be it enacted by the People of the State of Maine as follows:

- **Sec. 1. Transfer from Maine Recovery Fund to Department of Health and Human Services.** Notwithstanding any provision of law to the contrary, the State Controller shall transfer \$5,000,000 from the Office of the Attorney General, Maine Recovery Fund program, Other Special Revenue Funds account to the Department of Health and Human Services, Office of Child and Family Services District program, Other Special Revenue Funds account, by June 30, 2023.
- **Sec. 2. Transfer from Maine Recovery Fund to Department of Education.** Notwithstanding any provision of law to the contrary, the State Controller shall transfer \$2,000,000 from the Office of the Attorney General, Maine Recovery Fund program, Other Special Revenue Funds account to the Department of Education, School and Student Supports program, Other Special Revenue Funds account, by June 30, 2023.
- **Sec. 3. Transfer from Maine Recovery Fund to Department of Corrections, Juvenile Community Corrections.** Notwithstanding any provision of law to the contrary, the State Controller shall transfer \$1,000,000 from the Office of the Attorney General, Maine Recovery Fund program, Other Special Revenue Funds account to the Department of Corrections, Juvenile Community Corrections program, Other Special Revenue Funds account, by June 30, 2023.
- Sec. 4. Transfer from Maine Recovery Fund to Department of Corrections, County Jails Operation Fund. Notwithstanding any provision of law to the contrary, the State Controller shall transfer \$1,000,000 from the Office of the Attorney General, Maine Recovery Fund program, Other Special Revenue Funds account to the Department of Corrections, County Jails Operation Fund program, Other Special Revenue Funds account, by June 30, 2023.
- **Sec. 5. Appropriations and allocations.** The following appropriations and allocations are made.
