COMMITTEE AMENDMENT "A" to H P 690, L D 1095, "An Act to Amend the Laws Regarding Public Sector Bargaining in Public Schools by Providing an Exemption to the Time Limit on Negotiations"

Amend the bill by striking out the title and substituting the following

'An Act to Amend the Laws Regarding Public Sector Bargaining in Public Schools'

Amend the bill by striking out everything after the enacting clause and inserting the following

'Sec. 1. 26 MRSA §965, sub-§1, ¶B-1, as enacted by PL 2021, c 752, §2, is amended to read.

B-1 For a public employer that is a school ~~district~~ administrative unit and the bargaining agent representing ~~teachers~~ employees within that school ~~district~~ administrative unit, to meet within 10 days after receipt of written notice from the other party requesting a meeting for collective bargaining purposes, as long as the parties have not otherwise agreed in a prior written contract, except that explicit waivers of collective bargaining over wages, hours, working conditions and contract grievance arbitration in a prior written contract may not be enforced for purposes of this paragraph ~~This~~ The obligation to meet within 10 days of notice is suspended during the period between a referendum approving a new regional school unit and the operational date of the regional school unit, as long as the parties meet at reasonable times during that period.'

SUMMARY

This amendment replaces the bill. The amendment specifies that collective bargaining agreements in school administrative units may not waive the right to bargain over wages, hours, working conditions and contract grievance arbitration.

Fiscal Detail and Notes

This bill amends language enacted in Public Law 2021, chapter 752 associated with collective bargaining between school administrative units and the bargaining agents for teachers within the school administrative units to clarify that collective bargaining agreements in school administrative units cannot waive the right to bargain over wages, hours, working conditions and contract grievance arbitration. Public Law 2021, chapter 752 included ongoing General Fund appropriations of \$52,200 per year beginning in fiscal year 2022-23 to reimburse certain school administrative units for the mandated costs associated with the provisions included in that legislation. This bill does not change the fiscal impact of that enacted bill.
