19 20	Amend the bill in section 6 in subsection 2 in the first line (page 2, line 5 in L.D.) by striking out the following: "30%" and inserting the following: '25%'

SUMMARY

This amendment clarifies that other qualified subdivisions of State Government eligible for funding under the bond issue include executive branch departments and agencies; changes the percentage of funds that must be expended in support of nonmotorized trails from 30% to 25% and the percentage of funds that must be expended in support of motorized trails from 20% to 25%; changes the matching contributions requirement from 20% to 10%; and specifies that bond proceeds may not be used to dismantle state-owned tracks and ties for nonrail use except as provided for under the State Railroad Preservation and Assistance Act.
