Funds must be disbursed by the authority in one lump sum in the form of an interest-free loan a grant. 26 27 28 29 30 31	(2) Repayment of a loan may not be required until at least 60 days after the recipient of the loan has obtained a work permit, except that, if the recipient of the loan has obtained a work permit but has not obtained employment, repayment may not be required until at least 30 days after the recipient has obtained employment as long as the recipient is in compliance with the provisions of Title 22, section 4316-A.

33 34 35	This bill changes the Foreign Credentialing and Skills Recognition Revolving Loan Program to a grant program and increases the maximum allowable distribution of funds per applicant from \$700 to \$1,000.
