1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. Appropriations and allocations.** The following appropriations and

6 Initiative: Provides one-time funding to contract with an entity to provide free classes with
7 information, resources and support to understand child protective services, facilitated by
8 parents who have experienced the child protective services system or navigated multiple
9 complex systems.
