2 3	Sec. 1. 29-A MRSA §405, sub-§1, ¶A, as enacted by PL 1993, c. 683, Pt. A, §2 and affected by Pt. B, §5, is amended to read:
4 5	A. A registration expires on the last day of the month one year from the month of issuance, except for a registration under paragraph D.
6 7	Sec. 2. 29-A MRSA §405, sub-§1, ¶B, as enacted by PL 1993, c. 683, Pt. A, §2 and affected by Pt. B, §5, is amended to read:
8 9	B. When an application is made after the registration for the previous year has expired, the term of the renewal begins on the month of the issuance of the previous registration.
10	Sec. 3. 29-A MRSA §405, sub-§1, ¶D is enacted to read:
11 12 13 14	D. A person registering a motor vehicle under section 501, subsection 1 may choose to register that motor vehicle for a 2-year period. Such a registration expires on the last day of the month 2 years from the month of issuance. The excise tax under Title 36, section 1482 for the entire 2-year period must be paid at the time of registration.

26 27 28	(1) On new registrations of automobiles, trucks and truck tractors, the excise tax payment must be made prior to registration and is for a one-year the period from the date of registration under Title 29-A, section 405.
29	SUMMARY
30 31 32 33	This bill allows a person registering an automobile, pickup truck or sport utility vehicle to choose a 2-year registration for a fee in an amount 2% more than the fee for a one-year registration or \$20, whichever is less. The excise tax for the entire 2-year period is due at the time of registration.
