This amendment, which is the majority report of the committee, replaces the bill. It requires the County Corrections Professional Standards Council to convene a stakeholder group to examine the need for additional intensive case managers to assist in the transition of prisoners from county jails or other county correctional facilities into the community and examine the consistency among county jails of written policies regarding prisoner attendance at funerals, furloughs, visitation, education and discretionary accounts. It invites the participation in the stakeholder group of the Maine Sheriffs' Association and the Department of Health and Human Services, as well as others. It also requires the stakeholder group to submit a report on the findings of the stakeholder group to the Joint Standing Committee on Criminal Justice and Public Safety and authorizes the committee to report out legislation.

The amendment also includes an appropriations and allocations section that provides funding for the Department of Health and Human Services for 8 additional intensive case managers
