SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H P 855, L D 1341, "An Act to Modernize the Bureau of Motor Vehicles' Mobile Services"

Amend the amendment by striking out all of section 3 (page 1, lines 12 to 24 in amendment) and inserting the following

12 'Sec. 3. Funding. The Secretary of State shall modernize the Department of the 13 Secretary of State, Bureau of Motor Vehicles' mobile services including traveling units, 14 computer tablets, computers, punters, vehicle expenses and other information technology 15 to establish and operate a program to provide mobile services to include vehicle registration 16 and renewal or replacement of a driver's license or nondriver identification card This 17 program must be funded with up to \$1,000,000 in available prior year balances in the 18 Personal Services and All Other line categories in the Department of the Secretary of State, 19 Administration - Motor Vehicles program, Highway Fund account in accordance with 20 Public Law 2023, chapter 50, Part B The funds may be distributed by financial order upon 21 recommendation of the State Budget Officer and approval of the Governor'

SUMMARY

25 This amendment removes the appropriations and allocations section and replaces it 26 with a directive to the Secretary of State to modernize the Department of the Secretary of 27 State, Buleau of Motor Vehicles' mobile services including traveling units, computer 28 tablets, computers, printers, vehicle expenses and other information technology by 29 establishing and operating a program to provide mobile services for certain bureau services 30 The amendment provides that the program must be funded with up to \$1,000,000 in 31 available prior year balances in the Personal Services and All Other line categories in the 32 Department of the Secretary of State, Administration - Motor Vehicles program, Highway 33 Fund account in accordance with Public Law 2023, chapter 50, Part B The amendment
