The amendment retains the provisions of the bill directing that a death certificate reflect the desired gender identity of the individual who has died but removes the requirement that the gender field on a death certificate includes options for male, female and X Instead, the form or format of the death certificate may be determined by the State Registrar of Vital Statistics pursuant to the Maine Revised Statutes, Title 22, section 2701
