## Be it enacted by the People of the State of Maine as follows:

- **Sec. 1. 17-A MRSA §1105-A, sub-§1, ¶D,** as amended by PL 2021, c. 396, §4, is further amended to read:
  - D. At the time of the offense, the person trafficks in eocaine any compound, mixture or substance in a quantity of 112 grams or more containing a detectable quantity of cocaine or cocaine base. Violation of this paragraph is a Class A crime;
- **Sec. 2. 17-A MRSA §1105-A, sub-§1, ¶G,** as amended by PL 2011, c. 436, §1, is further amended to read:
  - G. At the time of the offense, the person trafficks in <u>any compound</u>, <u>mixture or substance in a quantity of 100 grams or more containing a detectable quantity of methamphetamine or amphetamine in <u>or</u> a quantity of 300 or more pills, capsules, tablets or units <del>or 100 grams or more containing any compound, mixture or substance containing a detectable quantity of methamphetamine or amphetamine</del>. Violation of this paragraph is a Class A crime;</u>
- Sec. 3. 17-A MRSA §1105-A, sub-§1, ¶H, as amended by PL 2001, c. 667, Pt. D, §24 and affected by §36, is further amended to read:
  - H. At the time of the offense, the person trafficks in heroin any compound, mixture or substance in a quantity of 6 grams or more containing a detectable quantity of heroin or 270 or more individual bags, folds, packages, envelopes or containers of any kind containing any compound, mixture or substance containing a detectable quantity of heroin. Violation of this paragraph is a Class A crime;
- **Sec. 4. 17-A MRSA §1105-A, sub-§1, ¶I,** as repealed and replaced by PL 2003, c. 688, Pt. B, §3, is amended to read:
  - I. At the time of the offense, the person trafficks in a quantity of 300 or more pills, capsules, tablets, vials, ampules, syringes or units containing any compound, mixture or substance containing a detectable quantity of a narcotic drug other than heroin, or any quantity of pills, capsules, tablets, units, compounds, mixtures or substances that, in the aggregate, contains 8,000 milligrams or more of oxycodone or 1,000 milligrams or more of hydromorphone. Violation of this paragraph is a Class A crime;
- **Sec. 5. 17-A MRSA §1105-A, sub-§1, ¶J,** as repealed and replaced by PL 2003, c. 688, Pt. B, §3, is amended to read:
  - J. At the time of the offense, the person trafficks in a quantity of 300 or more pills, capsules, tablets or units containing any compound, mixture or substance containing 3, 4-methylenedioxymethamphetamine, MDMA, or any other drug listed in section 1102, subsection 1, paragraph O. Violation of this paragraph is a Class A crime;
- **Sec. 6. 17-A MRSA §1105-A, sub-§1, ¶M,** as enacted by PL 2017, c. 460, Pt. F, §3, is amended to read:
  - M. At the time of the offense, the person trafficks in fentanyl powder any compound, mixture or substance in a quantity of 6 grams or more containing a detectable quantity of fentanyl powder or 270 or more individual bags, folds, packages, envelopes or containers of any kind containing any compound, mixture or substance containing a

l 2	detectable quantity of fentanyl powder. A violation Violation of this paragraph is a Class A crime.

1	This bill adds the trafficking of compounds, mixtures or substances containing a
5	detectable amount of a scheduled drug to the crime of aggravated trafficking of scheduled
5	drugs.
