3 **4. Terms, vacancies and council chair.** A member of the council appointed pursuant
4 to subsection 2, paragraph B serves for a term of 3 years Terms must be staggered so that
5 approximately ~~one-third~~ 1/3 of the council is renewed each calendar year If a member is
6 unable to complete the term, the commissioner shall appoint a member from the same
7 category of members listed in subsection 2, paragraph B as the member who vacated the
8 council to serve out the unexpired portion of the term ~~The commissioner shall determine~~
9 ~~how the council is to choose a chair and for how long the chair is to serve~~ The council
10 shall annually elect a chair and vice chair from among its members, each of whom serves
11 a term of one year '

26 provided to the public in each geographic region,

27 B Recommendations for the level of service and supporting infrastructure that should

29 infrastructure and a recommendation for any necessary additional funding, and

30 D A progress report on ~~recommendations contained in the implementation of the~~ most
31 recent statewide strategic transit plan for the department as well as the quinquennial
32 locally coordinated plan for regional transit under section 4209, subsection 2 '

SUMMARY

This amendment does the following

1 It specifies that the Department of Transportation's duty to facilitate and support the public transportation systems in the State to achieve accessibility, affordability and convenience is for the average person's mobility needs

2 It removes from the bill the requirement to reduce greenhouse gas emissions in accordance with emissions reduction targets

3 It changes the membership of the Public Transit Advisory Council

4 It removes the requirement that the Commissioner of Transportation determine how the council chooses a chair and for how long the chair serves It removes from the bill that the council is allowed to establish a steering committee The amendment requires the council to annually elect a chair and vice chair from among its members and provides that they serve a term of one year

5 It requires the council to meet 3 times a year instead of 4 times a year, as in the bill, and allows the council to create subcommittees and adopt bylaws and other policies to effectively govern the council's proceedings

6 It changes the council's report provided each year to include an assessment of the infrastructure provided in each geographic region It adds that the report must include recommendations for supporting infrastructure that should be provided and an estimate of the cost of providing that infrastructure and a recommendation for including additional funding as needed It removes from the bill the requirement that the report include a progress report on the implementation of the statewide mobility management program It removes from the bill the authority to report out a bill by the joint standing committees of the Legislature having jurisdiction over transportation matters and health and human services matters

7 It removes from the bill additional duties of the council, the requirement that the council set goals and the appropriations and allocations section
