Fiscal Detail and Notes

This bill subtracts from federal adjusted gross income for state income tax purposes an amount equal to a national service educational award received from the National Service Trust or an approved national service position or an educational loan payment earned through service with the Maine Service Fellows Program for tax years beginning on or after January 1, 2024. It will reduce General Fund revenue by \$57,000 in fiscal year 2024-25. It will also reduce Local Government Fund revenue by \$3,000 in fiscal year 2024-25.

The bill includes a one-time General Fund appropriation to the Department of Administrative Services, Bureau of Revenue Services for computer programming costs to add a new line to the individual income tax form and complete updates and testing to implement the income subtraction modification
